Interpreting Indicators of Rangeland Health is a qualitative assessment protocol used to determine ecosystem condition based on benchmark characteristics described in the Reference Sheet. A suite of 17 (or more) indicators are typically considered in an assessment. The ecological site(s) representative of an assessment location must be known prior to applying the protocol and must be verified based on soils and climate. Current plant community cannot be used to identify the ecological site.

1.	Number and extent of rills: None
2.	Presence of water flow patterns: None

5.	Number of gullies and erosion associated with gullies: 1 - 2 gullies associated with sit stable banks and bottoms with no erosion evident.
5.	Extent of wind scoured, blowouts and/or depositional areas: None
7.	Amount of litter movement (describe size and distance expected to travel): Fine - limited movement
3.	Soil surface (top few mm) resistance to erosion (stability values are averages - mos sites will show a range of values): Moderately resistant to erosion: aggregate stability = 5
9.	Soil surface structure and SOM content (include type of structure and A-horizon color and thickness): Weak to moderate medium platy structure, Dry color value 4-5, 3-11 inchanges, Moderate OM (1-7%)

Effect of community phase composition (relative proportion of different functional groups) and spatial distribution on infiltration and runoff: Significant ground cover (70 80%) and gentle slopes (0-8%) effectively limit rainfall impact and overland flow. Seasona subsurface flows from adjacent slopes augment available water.

	Dominant: Perennial, deep-rooted, bunch grasses

13.	Amount of plant mortality and decadence (include which functional groups are expected to show mortality or decadence): Normal decadence and mortality expected
14.	Average percent litter cover (%) and depth (in):
15.	Expected annual annual-production (this is TOTAL above-ground annual-production, not just forage annual-production): Favorable: 2200, Normal: 1800, Unfavorable: 1600 lbs/acre/year at high RSI
16.	Potential invasive (including noxious) species (native and non-native). List species which BOTH characterize degraded states and have the potential to become a dominant or co-dominant species on the ecological site if their future establishment and growth is not actively controlled by management interventions. Species that become dominant for only one to several years (e.g., short-term response to drought or wildfire) are not invasive plants. Note that unlike other indicators, we are describing what is NOT expected in the reference state for the ecological site: Western Juniper readily invades the site. Cheatgrass and Medusahead invade sites that have lost deep rooted perennial grass functional groups
17.	Perennial plant reproductive capability: All species should be capable of reproducing annually
